

PRIVACY POLICY

1. Introduction and General Terms

Sirius Group International Limited ("we" or "us") is committed to protecting your personal data when you use our Site. We want our services to be secure and provide convenient terms for our audience. This Privacy Policy applies to our use of any personal data you provide by completing special forms on the Site. To provide you with a full range of services, we sometimes need to collect information about you.

This Privacy Policy explains the following:

- what information we may collect about you;
- how we will use the information we collect about you;
- when we may use your information to contact you;
- whether we will disclose your data to anyone else;
- your choices regarding the personal information you have provided to us;
- the use of cookies on SIRIUS.INVESTMENTS and how to reject these cookies.

As stated above, we are committed to protecting your personal data. Whenever you provide such information, we are legally required to use your information in accordance with all laws regarding the protection of personal data.

The Site contains hyperlinks to websites owned and operated by third parties. These third-party websites have their own privacy policies, including cookies, and we strongly encourage you to review them. They will govern the use of personal data you submit or collect through cookies when you visit those websites. We are not responsible for the privacy practices of such third-party websites, and you shall use such websites at your own risk.

2. What information will we collect about you?

When you register to participate or receive services on any SIRIUS.INVESTMENTS website such as newsletters, contests, message boards, or register on SIRIUS.INVESTMENTS we may ask for your personal data. This may include your name, email, address, company name, and telephone number. We also use cookies and collect IP addresses (an IP address is a number that can uniquely identify a specific computer or other network devices on the Internet).

3. How will we use the information we collect about you?

We will use your personal data for several purposes, including the following:

• for "service administration purposes", which means that we may contact you for reasons related to the service you subscribed to (for example, to provide you with a password reset instructions or to notify you when a particular service has been suspended for maintenance);

• contact you about materials you have posted on the Site, including any content you provide;

- keep our internal records;
- provide you with the most convenient navigation.

We will notify you if we offer to use your personal data for any other purpose. You will also be given the option to refuse or revoke your consent, except for the cases listed above.

4. When will we contact you?

We may contact you:

• in relation to the operation of any service to which you have subscribed, to ensure that we can provide services to you;

- if you choose to receive further correspondence;
- in relation to any of your deposits to SIRIUS.INVESTMENTS;
- invite you to participate in surveys about our services (participation is always voluntary);
- for marketing purposes if you have expressly agreed to it.

5. Will we share your personal data with anyone else?

We will keep your information confidential except when disclosure is required or permitted by law. (for example, to government agencies and law enforcement agencies). Generally, we will only use your information within our company. However, sometimes we use third parties to process your data. We will demand that those third parties strictly comply with these policies, and we will require them not to use your personal data for their own business purposes.

6. How long will we keep your personal data?

We will keep your personal data in our systems for as long as necessary for the respective service or as specified in any relevant contract you have entered into with us.

7. How can you find out what personal data we keep about you?

Under the Data Protection Act, you have the right to request a copy of the personal data we hold about you and correct any inaccuracies. (We charge additional fees for information requests and will require you to verify your identity with 2 approved IDs with photos.)

We will make reasonable efforts to provide, correct or delete your personal data in our file storage.

9. Cookie policy: Information we collect from you

a. What is a cookie?

A cookie is a small amount of data, which often includes a unique identifier, sent to your computer or mobile phone ("device") browser from the website's computer and stored on your device's hard drive. Each website can send its own cookie to your browser if your browser settings allow it, but (to protect your privacy) your browser will only allow the website to access the cookies it has already sent you, not cookies sent to you by other sites. Many sites do this whenever a user visits their website to keep track of online traffic flows.

Cookies record information about your online preferences and allow us to tailor websites to your interests. Users can set their devices to accept all cookies, notify them when a cookie is sent, or not receive cookies at all. The latter means that certain personalized services cannot be provided to this user and, accordingly, you will not be able to fully use all the features of SIRIUS.INVESTMENTS. Every browser is different, so check your browser's Help menu to learn how to change your cookie settings.

During any visit to the SIRIUS.INVESTMENTS website, the pages you view and the cookie file are downloaded to your device. Many websites do this because cookies allow website publishers to do useful things, such as learning if the device (and possibly its user) has previously visited their website. This is done on a return visit by checking and detecting the cookie left there on the last visit.

b. How do we use cookies?

The information provided by cookies can help us analyze our visitors' profiles and help us provide you with a better user experience.

We also use several independent measurement and research companies. They collect information about visitors to our sites on our behalf using cookies, log file data, and code embedded in our Site. We use this type of information to help improve the service we provide to our users. We strictly require that third parties do not use any information for their own purposes, or business and other purposes. Other certain pages of SIRIUS.INVESTMENTS may use cookies for a specific reason, such as to ensure that you remain connected to our service.
